The Tahoe Truckee Earth Day Festival is a family friendly event open to organizations that engage the community in a constructive and positive manner.

ACCEPTABLE AND UNACCEPTABLE ACTIVITIES

Donations:

Donations may be solicited for your organization at the event.

Sales & Fundraising:

Non-profits are allowed to use Earth Day as a fundraising event. The sale of products must be fully and clearly disclosed and approval given. We do not allow sales that are in competition with Village tenants.

Information Distribution:

Distributing literature outside your booth area is strictly prohibited! Our intent is that customers not feel that they are being bothered by leafletters as they explore Earth Day.

Advocacy:

Advocacy or political activity must be clearly defined on the Earth Day application. We are looking for positive, content-rich booths and activities to inform, entertain and inspire festival attendees.

Examples of disallowed advocacy activities: election campaigning, critiquing businesses or promoting of specific political positions.

Personal Fundraising:

Fundraising for an event such as a breast cancer walk, is not eligible.

THE EARTH DAY COMMITTEE WILL HAVE FINAL DETERMINATION OF WHAT IS APPROVED.
